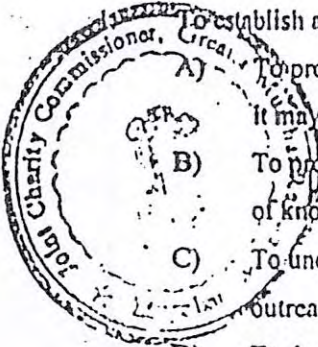


4. VESTING OF TRUST PROPERTIES :

8. MANAGING TRUSTEE

Dr. Gajanan D. Pol shall be the Managing Trustee through his life. As far as possible the post Managing Trustee shall be first given to the descendant of the Settlor (Dr. G. D. Pol.) and only when it is impossible to appoint Managing Trustee from the descendant of the Settlor's family the trustees shall select one amongst them to be the Managing Trustee. While deciding the descendants the preference shall be given first to wife, son, daughter (Elder daughter) (younger).

9. MODE OF SUCCESSION TO TRUSTEESHIP.

Managing trustees to appoint trustees in place of vacancies.

10. QUALIFICATION TRUSTEESHIP :

Any Hindu Male or Female of above 18 years of age, who is interested in the well being of the Trust and who undertake to devote full attention, power to activities of the Trust shall be eligible to become the Trustee.

11. DISQUALIFICATION OF THE TRUSTEESHIP

The trustee/s of the said Trust shall be disqualified to act as trustee/s if :

a) He/She acts against the interest of the Trust and does not abide by the Scheme of the Trust and Rules framed there under :

He/She commits any act of mal-feasance, misfeasance, misappropriation or breach of trust in respect of the Trust.

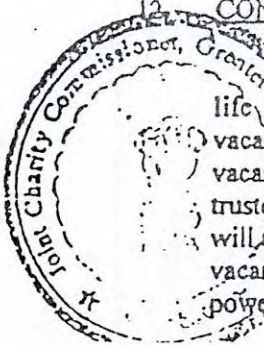
He/She is convicted of criminal offence involving moral turpitude or offence described under the Bombay Public Trusts Act, 1950/.

d) He/She voluntarily resigns or becomes physically incapable to act as Trustee or becomes of unsound mind, remains absent for three consecutive Board of Trustees meetings without prior permission of the Managing Trustee.

e) He/She is adjudged or declared him/her self-insolvent.

12. CONSENT OF NEW TRUSTEES TO ACT AND THEIR POWERS

The First three (3) trustees appointed as per this trust deed will be the life time trustees. The tenure of remaining trustee is for five years. Any vacancy/vacancies created by any reason, managing trustee will fill up the vacancy/vacancies. Trustee or trustees appointed in place of first three trustees for life time and other trustees for five years. The Managing trustee will appoint his successor, if he failed to appoint life time trustees fill up the vacancy by majority and the person appointed as a managing trustee shall hold power of managing trustee.

13. POWERS OF THE BOARD OF TRUSTEES :

For the accomplishment of the trusts of this Scheme and without prejudice to the generality of any powers hereby or by law conferred or implies of the following powers and authorities are hereby expressly conferred on the trustees that is to say.

- a. To see that the investments to stand in the name of the Trust.
- b. To sell, exchange, surrender, give-up, mortgage, Change, pledge, demise or dispose of any shares, bonds, debentures property movable or immovable for the time being subject to any of the provisions of this Scheme and upon any such exchange to give or receive any monies by way of consideration.
- c. To purchase, receive or otherwise acquire any immovable or movable property shares, debentures, bonds, etc. on any terms and conditions for all or any of the purposes of this Trust at such rates, rents premium, consideration, or hire or conditions and on such Terms and such period and with or without option for renewal redemption or purchase as the trustees may think fit
- d. To act according to the decision of the majority of trustees when the trustees are not unanimous.
- e. To give donation to any public charitable Trust subject to such terms and conditions as the trustees may think fit and proper.
- f. To decide all questions arising in the administration of trust properties hereof and including all questions relating to the interpretation of this scheme or exercise or non-exercise of any powers of the trustees and all questions otherwise concerning anything or matter relating to and connected with or arising out of this scheduled thereof. The decision of the Trustees on all any of the matters afore said stand final.



CHAIRMAN:

The Managing Trustee shall be the Chairman of the Board of Trustees. The Chairman shall preside at the meeting of Board of Trustees. He shall have one additional casting vote, in case of Equality of votes. The Chairman shall appoint the office bearer or office bearers (like General Secretary, Treasurer etc.) as per his requirement.

18. QUORAM:

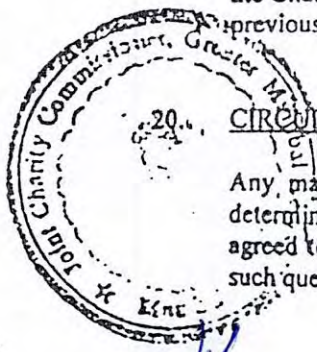
There shall be a quorum when at least 2/3rd trustees are present at any meeting of trustees.

21. MINUTE BOOK:
